Text Messages

By providing your phone number and signature on the portion of the Patient Consent form titled Consent to receive Phone Calls and Text Messages, you agree that Dermatologists of Central States (DOCS) and its partner practices may contact you via phone call or text message using pre-recorded/artificial voice messages, an automated telephone dialing system, or other automated means.
